Staff Recommendation:

Staff recommends the Board approve the Upper Colorado River Commission's System Conservation Pilot Program Projects as Water Conservation Projects subject to C.R.S. §§ 37-92-103(2) and 37-92-305(3)(c).

In June 2022, the Commissioner of the Bureau of Reclamation called on the Colorado River Basin States to create a plan to conserve an additional 2-4 million acre-feet of water above efforts already underway, in an effort to protect critical infrastructure at Lake Powell and Lake Mead. In July 2022, the Upper Division States responded with a Five-Point Plan, while recognizing that we were not the cause of the crisis and had limited options to respond due to ongoing and deep hydrologic and legal water shortages, coupled with depleted storage.

One component of this plan is reauthorization of the System Conservation Pilot Program (SCPP). This program entails temporary, voluntary, and compensated reductions in consumptive use across the Upper Basin for the purpose of mitigating the impacts of drought in the Upper Colorado River Basin. The SCPP was reauthorized by Congress, and a Request for Proposals was released in December 2022. Applications were accepted through March 1, 2023.

The SCPP will be administered by the Upper Colorado River Commission (UCRC) pursuant to a funding agreement executed on January 6, 2023, between the UCRC and the Department of the Interior through the Bureau of Reclamation. Part of the agreement includes a "Facilitation Exhibit" which describes how the UCRC will implement the funding agreement with Reclamation. The funding agreement requires that the proposed projects are to be selected based on criteria that shall be set by the UCRC. The criteria for the selection of pilot projects are set forth in the Facilitation Exhibit.

The funding agreement also includes a template implementation agreement that will be entered into between the UCRC and each participating water user after approval by the UCRC and Reclamation of a pilot project. The implementation agreement must be consistent with the terms of the funding agreement.

Under these agreements, the UCRC will grant final approval to projects for participation in the SCPP pursuant to criteria set by the UCRC.



Relevant to the concepts that the Pilot Program will explore, C.R.S. § 37-92-305(3)(c) provides that, except in Water Division 7, historical consumptive use in a change of water rights may not be reduced as the result of participation in a water conservation program approved by a state agency.¹

In addition, Section 37-92-103(2) defines abandonment of a water right such that any period of non-use of a water right shall be tolled if that water right is participating in "a water conservation program approved by a state agency..."

Thus, the CWCB Staff seeks to have the CWCB affirm that any projects participating in the SCPP are participating in a state-approved water conservation program.

Applications are currently under review by the UCRC to determine completeness and seek any missing or incomplete information, and to assess proposed conservation activities. Staff anticipates this preliminary review process will conclude by March 13, 2023, at which point CWCB Staff will provide the Board with a summary of the potential projects for CWCB approval pursuant to C.R.S §§ 37-92-103(2) and 305(3)(c) for final decision-making by the UCRC.

- (B) A water conservation program, including a pilot program, established through formal written action or ordinance by a water district, water authority, or municipality or its municipal water supplier for lands that are within the entity's jurisdictional boundaries;
- (C) An approved land fallowing program as provided by law in order to conserve water or to provide water for compact compliance; or
- (D) A water banking program as provided by law.



¹ C.R.S. § 37-92-305(3)(c):

⁽c) In determining the amount of historical consumptive use for a water right in division 1, 2, 3, 4, 5, or 6, the water judge shall not consider any decrease in use resulting from the following:

⁽I) The land on which the water from the water right has been historically applied is enrolled under a federal land conservation program; or

⁽II) The nonuse or decrease in use of the water from the water right by its owner for a maximum of five years in any consecutive ten-year period as a result of participation in:

⁽A) A water conservation program, including a pilot program, approved in advance by a water conservation district, water district, water authority, or water conservancy district for lands that are within the entity's jurisdictional boundaries or by a state agency with explicit statutory jurisdiction over water conservation or water rights;


Summary of Proposals Received

For the System Conservation Pilot Program 2023, the UCRC received 36 complete and responsive Colorado project proposals totaling 5,480 acres and 8,334 acre-feet of estimated conserved consumptive use. Below is a table summarizing the project proposals by basin.

Of these 36 proposals, 19 propose full-season fallowing. Two proposals include foregoing late-season reservoir water. One proponent proposed a large-scale project to administer participation (capped at 1,000 total acres) on a lottery basis. Nine projects include partial season irrigation, which for many would mean only irrigating in the fall to establish lower water use crops for subsequent years. Eight projects would replace alfalfa with lower water use, drought-resistant annual grasses. Of the 36 proposals, 21 include irrigated fields within larger ditch companies. Fifteen have water rights that are not under a formal ditch company.

Saved water in this program becomes "system water" and does not include shepherding downstream of the participant's point of diversion. Irrigation water will either be diverted at the ditch headgate and then "spilled" at some point down-ditch or will be bypassed at the headgate to ensure it is not available to non-participating ditch users. Proposals provide operating plans and general verification plans. Final verification plans will be included in the project contract. For many projects, verification will simply be ensuring that the land does not receive water - either via site visits or from satellite imagery. UCRC's consultants will perform any necessary verification.

Bill Summary

In 1942, Colorado entered into an interstate compact (compact)

with Nebraska and Kansas regarding the allocation of water from the Republican river basin (basin). Colorado ratified the compact in 1943. In 2016, Colorado, Nebraska, and Kansas signed a resolution (resolution) regarding a dispute about Colorado's compliance with the compact, through which resolution and its amendment Colorado agreed to retire 25,000 acres of irrigated acreage in the basin by 2029.

The bill requires the Colorado water center (center) in the Colorado state university to study the anticipated economic effects of the forced elimination of groundwater withdrawals within and surrounding the Colorado portion of the Republican river basin that could occur if Colorado fails to comply with the resolution. The center is required to prepare a progress report and, on or before January 1, 2026, a final report of the center's findings and conclusions from the study and to post both reports on the center's website. The center must present the progress and final reports to certain legislative committees.

Bill Summary

The bill appropriates the following amounts for the 2023-24 state fiscal year from the Colorado water conservation board (CWCB) construction fund to the CWCB or the division of water resources in the department of natural resources for the following projects:

• Continuation of the satellite monitoring system, \$380,000

- (**section 1** of the bill);
- Continuation of the floodplain map modernization program, \$500,000 (section 2);
- Continuation of the weather modification permitting program, \$500,000 (section 3);
- Continuation of the watershed restoration program, \$500,000 (section 6);
- Continuation of the Colorado Mesonet project, \$150,000 (section 7);
- Continuation of the weather forecasting partnership project, \$1,000,000 (section 8);
- Support for the division of water resources mobile field data collection application project, \$800,000 (section 9);
- Continuation of the reservoir enlargement assessment project, \$1,000,000 (section 11);
- Support for the central Colorado water conservancy district augmentation efficiency project, \$3,000,000 (section 15);
 and
- Support for the state water plan action advancement project, \$2,000,000 (section 16).

The bill directs the state treasurer to transfer the following amounts on July 1, 2023, from the severance tax perpetual base fund to the CWCB construction fund, and appropriates those amounts from the CWCB construction fund to the CWCB for the following projects:

- Continuation of the Platte river recovery implementation program, \$19,000,000 (section 12);
- Support for the upper Colorado river endangered fish recovery program and the San Juan river basin recovery implementation program, \$15,000,000 (section 13); and
- Additional and continued support for the Frying Pan Arkansas project, \$20,000,000 (section 14).

The bill directs the state treasurer to transfer the following amounts from the CWCB construction fund on July 1, 2023:

- \$2,000,000 to restore the fish and wildlife resources fund (section 4);
- Up to \$2,000,000 to the CWCB litigation fund (**section 5**); and
- \$2,000,000 to the water plan implementation cash fund for continuation of the water plan implementation grant program (section 10).

Section 17 appropriates \$10,600,000 of sports betting revenues from the water plan implementation cash fund and \$2,000,000 from the CWCB construction fund to the CWCB to fund grants that will help implement the state water plan.
